

The 7th Worldwide Uchinanchu Festival Countdown Photo Gallery Application and Terms of Use

If you (hereinafter referred to as the "Applicant") would like to apply for inclusion in the "Countdown Photo Gallery" organized by the 7th Worldwide Uchinanchu Festival Executive Committee (hereinafter referred to as the "Executive Committee"), please read the following carefully and agree to the Terms of Use before applying. By submitting an application, you are deemed to have agreed to these Terms of Use.

1. Purpose of Use

The photos posted on the Countdown Photo Gallery website will be used to build excitement leading up to the 7th Worldwide Uchinanchu Festival. Please note that the photos may be used for purposes other than the countdown to promote and publicize the event.

2. Copyright

(1) All rights, including copyright of the photo data submitted must belong to the applicant at the time of submission, or, if the copyright or other rights belong to a third party, the applicant must have obtained permission to use the data from that party.

(2) In order to prevent problems related to the image rights, etc. for a person depicted in the photo(s), it is the applicant's responsibility to obtain necessary permissions and approvals from the parties involved before submitting the photo(s). In addition, at the time of application, it is considered that the applicant has obtained consent from said party.

(3) The submitted photo data may be processed (trimmed, partially deleted, modified, etc.) and used by the Executive Committee without applicant's permission. In addition, the processed photo data will be the property of the Executive Committee.

3. Providing Photo Data

- (1) Please provide the photo data after agreeing to the Terms of Use.
- (2) Please note that we do not accept applications by mail. We will only accept applications via email.
- (3) We will not replace or return photos or other materials after the completion of your application.
- (4) We accept photos taken at any date.
- (5) The image file format can be either jpg. or gif., and there is no restriction on the size of the image file.
- (6) If you are under 15 years of age please apply after obtaining approval from your parent or guardian.
- (7) All expenses related to the production of photo data, application,(etc.) are the responsibility of the applicant.

4. Prohibited Matters

The photo data will not be used in any of the following cases. In addition, if it is revealed that the content of the application is in violation of these Terms, posting of the photo may be cancelled.

- (1) When there is a risk of harming or damaging the image of the 7th Worldwide Uchinanchu Festival.
- (2) When it violates or is likely to violate laws and regulations or public order and standards of decency.
- (3) When it is obviously intended to advertise a product, company, store, etc.
- (4) Photos for which usage permission cannot be obtained.
- (5) When the photo data will be used for sale, loan, and reproduction after the completion of the process.
- (6) The presence of other matters deemed inappropriate by the Executive Committee.
